Every Autumn the Foundation, along with a group of other non-profit organizations in the mental health field, co-sponsors a conference on the issue of recovery from mental illness. The Foundation pays for the conference cost. The conference is open to the public and is well attended by individuals with mental health issues as well.

Included among the grants the Foundation provides are those to individuals who are currently in treatment for mental illness for basic needs and services to enhance the quality of their lives and aid in their recovery. The Foundation funds medical co-pays for some of these individuals in treatment.
